



# Coronavirus - Summary and Links

When the news of Covid first broke, I like many people, was concerned about this virus and the impact it would have on us. Two things however, sparked curiosity about it. One was Covid's link to the Wuhan Institute of Virology which studied pathogens, and the other was the suggestion that it might have come from a wet market 40 minutes away from the lab. I read articles on the wet market theory and there was a plausibility to the idea to me for several reasons. One was because of the strange animals said to be for sale in the market. She related a story of traveling on a Chinese train overnight during which she could hear Chinese travelers spitting or blowing their noses outside the curtains of their berths into the hallway. The curtains enclosing the berths were used to wipe their noses and when she walked the hallway to the bathroom the floors were slippery from all the mucus and phlegm. A combination of eating strange things and unclean habits made the likelihood of catching a virus in Wuhan plausible.

A third thought crossed my mind, that of warfare. In studying the way the America military industrial complex works, with its massive budgets, DARPA research looking for anything that could be used in war, and previous research exposing the fact that among other things, [America's intelligence community had imported Nazis from Germany involved in torture and human experimentation in the prison camps](#) to learn [what they could from them](#). The best weapon to use against an enemy having massive resources, zero integrity, and that lies about everything would have to be biological. ## **Covid: An Overview**

[Shocking corruption in drug companies.](#) One reason, pharmaceutical companies fund candidates during elections. It is estimated that Pfizer spent \$25 million during the 2009 elections in the US. Such funding will favor improving the companies' profits and negatively impact public health objectives.

It is not an opinion to say drug companies will say anything to make a buck on the backs of people who need help and worse yet trust the people the drug companies influence directly, their personal doctors, to do no harm. The criminal convictions in the links above prove it. The other thing to know is all of the vaccines currently are experimental drugs issued with an Emergency Use Authorization. None have gone through the years of testing required for every other drug on the market. You, I and our children are simply lab rats. The statement that millions of people benefited from the vaccines based on the idea that there is a more favorable outcome if infected with Covid, is a con job. Or how about *"only X% of the children jabbed will develop heart conditions, which are easily treatable"* and then at the end of the ad in words spoken so quickly you can't catch them a disclaimer says *"there is a less than a .005% chance of your child dying from Covid or even catching it if you don't take the vaccine."*

### **Alternative Treatments, Doctors Censured, Unanswered Questions, Side Effects**

There are various approaches to the treatment of Covid, many of which are low cost, and there are hundreds of doctors worldwide attesting to their effectiveness as well as ongoing research looking for solutions. The alternative treatments of off label approved drugs are in use worldwide and there are medical studies, reviews and controlled trials that prove as much. However, there is a massive movement to prevent their use and discredit physicians that do so, some of whom are leading authorities on infection, vaccines and hundreds of others that are successfully treating patients in the tens of thousands.

I am not a lawyer, but the FDA issued Emergency Use Authorizations for the vaccines (EUAs) supported by a Secretary of Health and Human Services (HHS) declaration that circumstances exist to justify the emergency use of drugs and biological products during the COVID-19 pandemic that have not undergone the same type of review as an FDA-approved or cleared product. The FDA may issue an EUA when certain criteria are met:

- 1) there are no adequate, approved, and available alternatives, and
- 2) the potential benefits of the product outweigh the known and potential risks of the product.

However, if the government engages in a systematic program to prevent “alternatives” that show they do work to be used and also blocks risk information from coming out, as the many doctors in the links prove, then on what basis are the EUAs legally justified?

From a legal perspective, one thing that may blow up the entire narrative of the EUA authorizations claiming there are no alternative products to treat Covid is the fact that the [Office of the Attorney General of the State of Nebraska, under Douglas J. Peterson, issued an opinion](#) that not only were there a number of alternative drugs available off label to treat covid with demonstrated efficacy but also that the law allows Doctors to prescribe them:

"we conclude that governing law allows physicians to use FDA-approved medicines that are unproven for a particular off-label use so long as (1) reasonable medical evidence supports that use and (2) a patient's written informed consent is obtained. In the context of this ever-changing global pandemic, we note that it is appropriate to consider medical evidence outside of Nebraska and to give physicians who obtain informed consent an added measure of deference on their assessment of the available medical evidence."

The Attorney General's opinion lists a number of these drugs, backs the opinion up with detailed research and further opines with regards to ivermectin:

"Why would ivermectin's original patentholder go out of its way to question this medicine by creating the impression that it might not be safe? There are at least two plausible reasons. First, ivermectin is no longer under patent, so Merck does not profit from it anymore. That likely explains why Merck declined to "conduct clinical trials" on ivermectin and COVID-19 when given the chance. 178 Second, Merck has a significant financial interest in the medical profession rejecting ivermectin as an early treatment for COVID-19. "[T]he U.S. government has agreed to pay [Merck] about \$1.2 billion for 1.7 million courses of its experimental COVID-19 treatment, if it is proven to work in an ongoing large trial and authorized by U.S. regulators. "179 That treatment, known as "molnupiravir, aims to stop COVID-19 from progressing and can be given early in the course of the disease. "180 On October 1, 2021, Merck announced that preliminary studies indicate that molnupiravir "reduced hospitalizations and deaths by and that same day its stock price "jumped as much as 12.3% "182 Thus, if low-cost ivermectin works better than—or even the same as—molnupiravir, that could cost Merck billions of dollars."

When investigating a subject, I think the advice given by Richard Feynman, quoted below. Feynman is a Nobel prize winning scientist who as an example of his logical approach explained how [NASA officials ignored problems with the O-rings](#) that sealed the Challenger spacecraft fuel tanks resulting in the death of the seven astronauts on board. [NASA's faulty thinking is attributed to group think](#) which appears to be the case with the CDC, FDA and the Biden administration as well as much of the politically motivated health guidance in use worldwide. Nor should it pronounce on the validity of economic, historic, religious, or philosophical doctrines. Instead, it has a duty to its citizens to maintain the freedom, to let those citizens contribute to the further adventure and the development of the human race."*
